CORE BRIEF TO MANAGEMENT GROUP MEMBERS

MEETING HELD ON 24 May 2018

This briefing sets out the key areas of discussion and decision. It aims to ensure the Management Group members have a common core brief to disseminate within their organisation.

1. Minutes of the Previous Meeting and Action Log

The minutes of the meeting held on 26 April 2018 were approved.

Members noted the action log and received an update on:

- MG001 NWIS Project on English Data. Members agreed that a formal closure report be presented at the July meeting of Management Group
- MG049 BMT Investment in South Wales 2016/17
- MG052 BAHA and Cochlear: 26 Week Waiting Time Standard
- MG054 Revised Commissioning Policies for Specialised Rehabilitation. It was noted that this action had been rolled into MG055 and therefore Members agreed that this action be closed.
- MG055 Specialised Rehabilitation. Members noted that this action was included in the Performance Report for the meeting and therefore agreed that this action be closed.
- MG056 Commissioning Policies: Approval Process.
- MG063 Implementation of the WHSSC Integrated Commissioning Plan (ICP) for Specialised Services 2018-21. Members agreed to receive the PET meeting notes outside the meeting and therefore agreed that this action be closed.

6. Provision of Congenital Heart Disease Services following NHS England's Public Consultation

Members received an update on the current situation with regard to the changes in delivery of care for Congenital Heart Disease services following NHS England's review of services and describing the impact for Welsh patients.

- **Undertake** urgent work to understand the implications for Wales of the Level 2 and Level 3 standards prior to their approval.

• Gender Identity Services

Members noted that Andrew Goodall, Welsh Government's Director General for Health and Social Services and Chief Executive of NHS Wales had issued a Letter of Direction to all Welsh Local Health Board CEOs pushing for the implementation of a Gender Identity Pathway.

• Immunology

Members received headline analysis regarding pressure that emerged throughout the last year in terms of immunology. Members noted the holding position for WHSSC to continue to process secondary immunodeficiency case approvals.

• Perinatal Mental Health
